

REMINDERS & RECOMMENDATIONS

Wiring Reminder

The maximum distance between the controller and the reader head is 50m. Beware of mains (240Vac) connections. Recommended cables> 3 twisted pairs (EIA-485 standard), 3P SYT 24 AWG. Make sure the drain wire PE is connected.

Environment

The door controller must be installed internally. The reader head must be installed in a sheltered location from the weather. Operating temperature range of -10° C to $+ 50^{\circ}$ C.

Installation Recommendation


To limit back EMF spikes, the varistor must be installed across the supply terminals of the lock.

Recommended power supplies (12 VDC)


Power supplies must be 12Vdc with a minimum current provision of 1A. Please ensure you have taken into account the power requirements of the lock.


Power must be a limited power source, compliant with EN 600950-1.


FIRST TIME POWER UP



2 REGISTRATION OF FINGERPRINTS UP TO 500 USERS




Note: If registration is not completed within 60 seconds, the unit will revert to standby














Note: After deleting a Master Card, the next Master Card presented will automatically be added - as indicated by the green LED





A General Alarm will be activated:

- If the door contact (CP) is connected and there has been an attempt to force the door; or the door was not closed within 60 seconds of a valid transaction.
- If there is loss of communication between the controller and the reader head for more than 25 seconds.
- If there is an attempt to remove the reader head (tamper detection).

While in programming mode, inaction will revert the reader head to sleep mode.



Important note: The user cards are unique, and used for the registration and deletion of users. It is important to note which user card is registered to which user, and all cards should be kept in a safe and secure place.
